

RESOLUTION R-2020-15

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 111 WITH
THOMAS ENGINEERING GROUP, LLC., FOR PHASE 3 CONSTRUCTION RESIDENT ENGINEERING
SERVICES FOR PRESIDENT STREET BETWEEN HARRISON AVENUE AND GENEVA ROAD
FOR A TOTAL AMOUNT NOT TO EXCEED \$35,969.28**

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Thomas Engineering Group, LLC., 55 West 22nd Street, Suite 300, Lombard, Illinois, 60148, for Phase 3 Construction Resident Engineering Services for President Street Between Harrison Avenue and Geneva Road; and

WHEREAS, the City prepared a Request for Proposal package (RFP Number 20-06) that included Phase 3 Construction Resident Engineering Services for President Street Between Harrison Avenue and Geneva Road; and

WHEREAS, it was determined by the City that Thomas Engineering Group, LLC., meets the City's needs; and

WHEREAS, the City budgeted funds in the Capital Projects Fund in the amount of \$35,969.28 for Phase 3 Construction Resident Engineering Services for President Street Between Harrison Avenue and Geneva Road; and

WHEREAS, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Phase 3 Construction Resident Engineering Services for President Street Between Harrison Avenue and Geneva Road.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 111, with Thomas Engineering Group, LLC., 55 West 22nd Street, Suite 300, Lombard, Illinois, 60148 for Phase 3 Construction Resident Engineering Services for President Street Between Harrison Avenue and Geneva Road at the pricing set forth in Thomas Engineering Group, LLC.'s Fee Proposal, which is incorporated into City of Wheaton Agreement No. 111; and that a copy of that certain City of Wheaton Agreement No. 111 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-15 and is hereby incorporated into this Resolution as if fully set forth herein.
