

**RESOLUTION R-2020-25**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 118  
WITH WEBSTER, MCGRATH & AHLBERG, LTD., FOR ENGINEERING  
SERVICES FOR NEW SIDEWALKS FOR A TOTAL AMOUNT NOT TO EXCEED \$28,900**

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Webster, McGrath & Ahlberg, Ltd., 207 S. Naperville Road, Wheaton, Illinois, 60187, for Engineering Services for New Sidewalks; and

**WHEREAS**, the City conducted a Request for Proposal (RFP Number 20-24) process and received and reviewed two submittals for engineering services for new sidewalks; and

**WHEREAS**, Webster, McGrath & Ahlberg, Ltd., submitted a proposal to provide engineering services for new sidewalks in the amount of \$28,900; and

**WHEREAS**, the City has a satisfactory pre-existing relationship with Webster, McGrath & Ahlberg, Ltd., and its proposal meets the City's needs; and

**WHEREAS**, the City budgeted funds in the Capital Projects Fund for Engineering Services for New Sidewalks; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Engineering Services for New Sidewalks.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 118, with Webster, McGrath & Ahlberg, Ltd., 207 S. Naperville Road, Wheaton, Illinois, 60187 for Engineering Services for New Sidewalks in an amount not to exceed \$28,900; and that a copy of that certain City of Wheaton Agreement No. 118 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-25 and is hereby incorporated into this Resolution as if fully set forth herein.
