CITY NOTES

Meeting Cancellations

City meetings of City boards and commissions remain cancelled until at least May 30. The exception will be those boards/commissions that have pending business that cannot be postponed. In such cases, the number of people in attendance will be limited per state mandates, and social distancing procedures will be followed while allowing virtual attendance to residents. The Wheaton City Council will continue to meet to conduct City business.

Bulk Item Collection Remains Suspended

Governor Pritzker's New Executive Order Begins May 1

Face coverings will be required in certain public settings

Governor Pritzker announced on Friday, April 24 that he would be signing a new Executive Order that would modify and extend the state's stay-at-home order beginning May 1 and lasting through May 30.

Provided are some highlights from the Executive Order that include new modifications for businesses, re-opening of some outdoor spaces and recreational activities, and the inclusion of a new requirement of face-coverings for individuals in public settings.

Modifications for Businesses

Retail stores designated as non-essential businesses may re-open to fulfill telephone and

online orders through pick-up outside the store and delivery.

All essential businesses and manufacturers will be required to provide face-coverings to all employees who are unable to maintain six-foot social distancing. Greenhouses, garden centers, nurseries, and animal groomers may re-open as essential businesses.

Face-Coverings Required at Indoor Public Places

Beginning May 1, individuals will be required to wear face-coverings when in public places where six-foot social distancing can not be maintained. Face-coverings will be required in indoor spaces such as grocery stores. The new requirement applies to

pickup service, Lakeshore Recycling Systems continues to temporarily suspend its bulk item and white goods collection until further notice. Bulk items include things too large to fit into your garbage cart, such as mattresses and toilets; white goods include appliances such as refrigerators or air conditioners. Please hold onto these items until a later date rather than placing them at the curb for pickup.

No Garbage Pickup

Due to the Memorial Day holiday, there will be no garbage/recycling/yard waste pickup on Monday, May 25. All pickups for the week of May 25 will be one day later than usual.

Police Department Offering Child Safety Seat Assistance via Facetime

While the Wheaton Police Department is currently unable to provide in-person child safety seat inspections, officers are scheduling Facetime appointments to provide assistance. Please call 630-260-2161 for more information.

City Council Approves Executive Orders Related to COVID-19

At its April 20 meeting, the Wheaton City Council's approved several changes to recognize financial hardships and promote the health and safety of our community. The full Executive Orders are available on the City's website at www.wheaton.il.us/COVID-19.

No Soliciting

To reduce the possibility of spreading COVID-19 in our community, the City has temporarily prohibited all in-person soliciting for both commercial and non-commercial purposes. This means that no door-to-door soliciting of any kind is allowed during this temporary local state of emergency.

Late Fees Waived for City Utility Bills; Service Disconnections Suspended

The City is waiving late fees for non-payment of City utility bills issued for March, April and May. In addition, the City is

suspending service disconnections for non-payment of utility bills, both for commercial and residential customers.

Parking Tickets

These changes also include a delay in assessing a penalty for parking tickets issued after March 20 until a later date to be determined by the City.

Changes to Leased Parking Permit Due Date

The City is extending

the due date for second quarter leased parking permits to June 1. The City will waive penalties and cancellations if payment is made by June 1.

Other Changes to Assist Local Businesses

- The City is providing a three-month refund for many types of liquor licenses.
- Fire alarm monitoring service fees for April 1 through June 30 are waived.

City Prohibits General Burning of Yard Waste, Garbage, or Other Materials

General open burning of yard waste, garbage, or other materials including leaves is prohibited. Recreational and food-related fires conducted within commercial and approved containers such as grills and manufactured portable fireplaces are allowed with only seasoned firewood to be

burned in fireplaces or permit approved fire pits. Residents must attain a special permit from the Fire Department for small ground bonfires. View [information about 'Open Burning'](#) on the City's website.

Library Closure

The Wheaton Public Library (WPL) remains closed until further notice. Anyone living within the boundaries of School District 200 can obtain a temporary

Wheaton Library Card to access eContent and online resources. Those living within the district boundaries can sign up for a card at wheatonlibrary.org/getcard. In addition, WPL staff has been working to develop a Virtual Library which will contain free online resources, virtual tours, online performances, and WPL databases and eContent, which can be accessed wheatonlibrary.org/getcard.

City Appoints New Commission Members

The Wheaton City Council has appointed Elle Withall to a 3-year term on the Downtown Wheaton Design Review Board, reappointed Michael Rybinski to 3-year term on the Housing Commission, and reappointed Mark Taylor and Robert Wolgemuth to 3-year terms on the Liquor Control Commission.

Resurfacing of President Street and Manchester Road Underway



Crews began working on resurfacing portions of President Street and Manchester Road. The City anticipates these improvements will be completed by the end of July, barring unforeseen circumstances. The project limits include: President Street from Harrison Avenue to Geneva Road, and

Manchester Road from County Farm Road to Gables Boulevard.

Both projects will consist of spot curb replacements and sidewalk replacement at intersections for ADA compliance, followed by pavement resurfacing. During construction, electronic message boards will be in place to notify drivers of detours and road work.

U.S. Census: Help Wheaton Reach 100%

The U.S. Census response rate for the State of Illinois is currently at 55.7%, with the City of Wheaton's current Census response rate being at 72.6% as of April 25. Let's continue to make Wheaton count and keep pushing for 100%!

Be Prepared for Severe Weather Throughout the Year

Preparing for floods, tornadoes and severe thunderstorms before they strike will help you stay safe throughout the year.

The Illinois Emergency Management Agency provides these fast facts about tornadoes to help you be prepared for possible severe weather:

- Illinois ranks fourth in the United States for the most tornadoes per square mile.
- The majority of Illinois tornadoes have occurred between April 1 and June 30 and between the hours of 3 p.m. and 10 p.m. However, tornadoes have occurred every month of the year at all hours of the day.
- Nearly 20 percent of all tornadoes in Illinois occur after dark.
- On average, 53 tornadoes occur each year in Illinois.
- There were 48 tornadoes reported in Illinois during 2019, which resulted in 1 injury and nearly \$2 million in property damage.

Tips to Stay Safe

- It is critical that someone at home, work or wherever people gather monitors weather

conditions, regardless of the time of day. Many deadly tornadoes occur at night.

- Monitor watches and warnings in your areas using a weather alert radio, cell phone app, local TV, local radio or the Internet.

- Do not rely solely on outdoor warning sirens, especially if you are asleep. If it is safe to do so, contact family members and friends when you become aware of a tornado that may threaten them.

- Check the weather forecast before leaving for extended outdoor periods and postpone plans if severe weather is imminent.

- Determine the best location in your home and workplace to seek shelter when threatened by a tornado. A basement or cellar will usually afford the best protection. If an underground shelter is not available, identify an interior room or hallway on the lowest level. The best areas are closets, small interior hallways and bathrooms without windows.
