

ORDINANCE NO. O-2020-29

**AN ORDINANCE AMENDING THE CALENDAR YEAR 2020 BUDGET  
CONTAINED IN ORDINANCE NO. O-2019-60**

**WHEREAS**, the City of Wheaton has heretofore adopted the Illinois Municipal Budget Law as set out in 65 ILCS 5/8-2-9.1. through 5/8-2-9.10, and as may be qualified by the City's home rule authority under Article VII, Section 6 (i) of the Constitution of the State of Illinois; and

**WHEREAS**, the City Council of the City of Wheaton passed Ordinance No. O-2019-60 adopting the annual budget of the City of Wheaton for the fiscal year commencing January 1, 2020; and

**WHEREAS**, said ordinance was filed with the County Clerk of DuPage County in accordance with the applicable State statutes; and

**WHEREAS**, the City Council desires to amend the budget contained in Ordinance No. O-2019-60; and

**WHEREAS**, funds are available to amend the budget for the fiscal year commencing January 1, 2020; and

**WHEREAS**, this budget amendment is adopted pursuant to the City of Wheaton's home rule authority.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Wheaton, Illinois:

**Section 1.** That the expenditure budget of the Library General Fund be increased in the amount of \$130,747 in order to amend the following account budget:


