

RESOLUTION R-2020-69

**A RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) REPLACEMENT VEHICLES FOR
UNITS 90 AND 99 THROUGH THE SUBURBAN PURCHASING COOPERATIVE (SPC) JOINT
PURCHASING PROGRAM WITH CURRIE MOTORS FLEET FOR A TOTAL AMOUNT OF \$54,062**

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the Suburban Purchasing Cooperative (SPC) has publicly and competitively bid for vehicles and heavy equipment sales; and

WHEREAS, SPC has awarded agreement #150 to Currie Motors Fleet located in Frankfort, Illinois, for vehicles and heavy equipment sales and has made the agreement available to other public entities; and

WHEREAS, vehicle units 90 and 99 used by the Water Division of the Public Works Department have accumulated sufficient age, usage, and wear to require replacement; and

WHEREAS, the City budgeted funds in the Fleet Services Fund in the amount of \$45,548 and reserves are available to accommodate the additional cost; and

WHEREAS, the corporate authorities of the City of Wheaton find it reasonable and appropriate to purchase two (2) Ford T150 vans for the Water Division of the Public Works Department, for a total amount not to exceed \$54,062 through the SPC agreement #150 with Currie Motors Fleet.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The City's Purchase Order #2021079 for the purchase of two (2) Ford T150 vans for the Water Division of the Public Works Department through the SPC agreement #150 with Currie Motors Fleet located in Frankfort, Illinois, for a total amount not to exceed \$54,062, is hereby authorized (the "Purchase") and City staff is authorized to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction. A copy of the City's Purchase Order #2021079 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-69 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the SPC agreement #150 is on file with the City Clerk's office as Exhibit A to Purchase Order #2021079, and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.
