

RESOLUTION R-2020-80

**A RESOLUTION AUTHORIZING THE PURCHASE OF REPLACEMENT
HYDRAULIC EXTRICATION RESCUE TOOL SYSTEMS FROM EMC FIRE
FOR A TOTAL AMOUNT NOT TO EXCEED \$93,803.50**

WHEREAS, the City Fire Department currently uses Genesis Rescue Systems hydraulic extrication rescue tool systems which have been reliable in both operations and maintenance over the past eight years but due to their age and the changes to vehicle construction are in need of replacement with updated models; and

WHEREAS, the City has identified EMC Fire of Channahon, Illinois as the sole source provider of Genesis Rescue Systems for DuPage County and that the needed hydraulic extrication rescue tool systems equipment is available for purchase through the Houston Galveston Area Council (HGAC) Cooperative Purchasing Program agreement #EE08-19; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the City prepared a Request for Quote package (RFQ Number 20-92) to EMC Fire, for the purchase of Genesis brand hydraulic extrication rescue tool systems in DuPage County; and

WHEREAS, it is determined by the City that the quote received from EMC Fire in the amount of \$93,803.50 for Genesis brand hydraulic extrication rescue tool systems equipment meets the City's needs; and

WHEREAS, the City budgeted funds in the Capital Equipment Replacement Fund in the amount of \$100,000 for hydraulic extrication rescue tool systems equipment; and


WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into a purchase agreement with EMC Fire of Channahon, Illinois, for the purchase of Genesis hydraulic extrication rescue tool systems for a total amount not to exceed \$93,803.50.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The City's Purchase Order #2021099 for the purchase of Genesis hydraulic extrication rescue tool systems for the Fire Department through the HGAC cooperative agreement #EE08-19 with EMC Fire located in Channahon, Illinois, for a total amount not to exceed

\$93,803.50, is hereby authorized (the "Purchase") and City staff is directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction. A copy of the City's Purchase Order #2021099 and sole source letter is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-80 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the HGAC agreement #EE08-19 is on file with the City Clerk's office as Exhibit A to Purchase Order #2021099, and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.
