

RESOLUTION R-2020-109

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 160 WITH
CHICAGOLAND PAVING CONTRACTORS, INC., FOR HOT MIX ASPHALT SURFACE REMOVAL
SERVICES FOR A TOTAL AMOUNT NOT TO EXCEED \$55,000**

WHEREAS, the City prepared a bid package (Bid Number 20-110) that included Hot Mix Asphalt Surface Removal Services; and

WHEREAS, the City solicited bids in a public bidding process for a one (1) year agreement and bids were publicly opened and read on November 4, 2020, at 11:00AM. Chicagoland Paving Contractors, Inc., was determined to be the lowest, responsive, responsible bidder with a bid amount of \$55,000, with an option to extend the agreement for two (2) additional one (1) year terms, upon the same pricing, terms, and conditions; and

WHEREAS, the City budgeted funds in the General Fund in the amount of \$55,000 for Hot Mix Asphalt Surface Removal Services for the Streets Division of the Public Works Department; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Hot Mix Asphalt Surface Removal Services; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Chicagoland Paving Contractors, Inc., 225 Telser Rd., Lake Zurich, Illinois, 60047, for Hot Mix Asphalt Surface Removal Services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 160 with Chicagoland Paving Contractors, Inc., 225 Telser Rd., Lake Zurich, Illinois, 60047, for Hot Mix Asphalt Surface Removal Services for a one (1) year term, for a total amount not to exceed \$55,000, with the option to extend the agreement at the same pricing, terms, and conditions for two (2) additional one (1) year terms; and that a copy of that certain City of Wheaton Agreement No. 160 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-109 and is hereby incorporated into this Resolution as if fully set forth herein.
