

ORDINANCE NO. O-2020-45

**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE
FISCAL YEAR BEGINNING JANUARY 1, 2021 AND ENDING DECEMBER 31, 2021
IN AND FOR THE CITY OF WHEATON SPECIAL SERVICE AREA NUMBER TWO**

BE IT ORDAINED by the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule powers, as follows:

Section 1: Findings. The City of Wheaton Special Service Area Number Two has been created by Ordinance No. E-1914, entitled, "An Ordinance Establishing City of Wheaton Special Service Area No. 2 (Central Business District)," adopted February 8, 1993, and effective as of February 9, 1983, no petition having been filed opposing the creation of the special service area, pursuant to the Illinois Special Service Areas Act (Ill. Rev. Stat. 1981, ch. 120, par. 1301 *et seq.*), currently codified as the Special Service Area Tax Law, 35 ILCS 200/27-5 *et seq.* Special Service Area Number Two consists of the territory described in the ordinance aforesaid. The City of Wheaton is now authorized to levy taxes for special services in Special Service Area Number Two as described in the aforesaid ordinance.

Section 2: The total amount of appropriations for all the purposes to be collected from the tax levy of the current fiscal year in Special Service Area Number Two is ascertained to be the sum of \$39,400.

Section 3: The following sums shall be levied upon the taxable property as defined in the Public Act 88-455 as codified in the Illinois Property Tax Code, in the City of Wheaton Special Service Area Number Two; said tax to be levied for the fiscal year beginning January 1, 2021 and ending December 31, 2021.


Section 4: This tax is levied pursuant Article 7 of the Constitution of the State of Illinois and pursuant to the Special Service Area Tax Law, 35 ILCS 200/27-5 *et seq.*, as amended from time to time, and pursuant to Ordinance No. E-1914.

Section 5: The \$39,400 tax levy for Special Service Area Number Two is certified to the County Clerk of DuPage County, Illinois. The City of Wheaton determines this \$39,400 tax levy to be the total amount required to be raised by taxation for the current fiscal year of the City for Special Service Area Number Two. The City Clerk of Wheaton, Illinois, is directed to file with

the County Clerk of DuPage County, on or before the time required by law, a certified copy of this ordinance.

Section 6: All ordinances or parts of ordinances in conflict with these provisions are repealed.

Section 7: This ordinance shall become effective from and after its passage, approval, and publication in the manner prescribed by law.
