

**RESOLUTION R-2020-115**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 164 WITH STRYKER  
SALES CORPORATION FOR PREVENTATIVE ONSITE MAINTENANCE AND REPAIRS FOR  
LIFEPAK 15 CARDIAC MONITORS FOR A FOUR (4) YEAR AGREEMENT AND TOTAL AMOUNT  
NOT TO EXCEED \$24,480**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City prepared a Request for Quotation package (RFQ Number 20-122) for Stryker Sales Corporation for Preventative Onsite Maintenance and Repairs of Lifepak 15 Cardiac Monitors; and

**WHEREAS**, Stryker Sales Corporation is the sole source provider for the Lifepak 15 Cardiac Monitors currently in place at the City. A sole source letter is attached hereto and incorporated herein as if fully set forth as Exhibit A; and

**WHEREAS**, Stryker Sales Corporation submitted a proposal to provide preventative maintenance and repair services for the City's Lifepak 15 Cardiac Monitors for four (4) years for a total amount not to exceed \$24,480 (\$6,120.00 each year); and

**WHEREAS**, the City budgeted funds in the CY21 General Fund-Medical/Rescue account for a total amount of \$7,300 for Preventative Onsite Maintenance and Repairs of Lifepak 15 Cardiac Monitors; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the Request for Quotation and the agreement contained in the City's quotation package for Preventative Onsite Maintenance and Repairs of Lifepak 15 Cardiac Monitors; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Stryker Sales Corporation, 3800 Centre Avenue, Portage, Michigan, 49009, for Preventative Onsite Maintenance and Repairs of Lifepak 15 Cardiac Monitors.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 164 with Stryker Sales Corporation for Preventative Onsite Maintenance and Repairs of Lifepak 15 Cardiac Monitors for a four (4) term and for a total amount not to exceed \$24,480; and that a copy of that certain City of Wheaton Agreement No. 164 is on file with the City Clerk's office as Exhibit B to this Resolution R-2020-115 and is hereby incorporated into this Resolution as if fully set forth herein.
