

RESOLUTION R-2020-113

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 163 WITH
INSITUFORM TECHNOLOGIES, USA, LLC. FOR THE 2020 SANITARY AND STORM MAIN
REHABILITATION FOR A TOTAL AMOUNT NOT TO EXCEED \$139,018**

WHEREAS, the City prepared a bid package (Bid Number 20-131) that included the 2020 Sanitary and Storm Main Rehabilitation; and

WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on December 14, 2020, at 11:00 AM and Insituform Technologies, USA, LLC. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$139,018; and

WHEREAS, the City budgeted funds in the CY21 Sanitary Sewer Fund for an amount of \$200,000 and \$115,000 in the Capital Projects Fund for the 2021 Storm Sewer Main Rehabilitation; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for the 2020 Sanitary and Storm Main Rehabilitation; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Insituform Technologies, USA, LLC., 17988 Edison Avenue, Chesterfield, Missouri, 63005, for the 2020 Sanitary and Storm Main Rehabilitation


NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 163 with Insituform Technologies, USA, LLC., 17988 Edison Avenue, Chesterfield, Missouri, 63005, for the 2020 Sanitary and Storm Main Rehabilitation, for a total amount not to exceed \$139,018; and that a copy of that certain City of Wheaton Agreement No. 163 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-113 and is hereby incorporated into this Resolution as if fully set forth herein.
