

RESOLUTION R-2021-07

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 176 WITH
MDS TECHNOLOGIES, INC. TO PROVIDE PAVEMENT MANAGEMENT SYSTEM
UPDATES FOR A TOTAL AMOUNT NOT TO EXCEED \$35,950**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City prepared a Request for Quotation package (RFQ Number 21-09) that included Pavement Management System Updates; and

WHEREAS, MDS Technologies, Inc. submitted a proposal to provide Pavement Management System Updates for a total amount not to exceed \$35,950; and

WHEREAS, the City budgeted funds in the Capital Projects Fund for an amount of \$40,000 for Pavement Management System Updates; and

WHEREAS, both parties agree to the terms and conditions set forth in the RFQ and the agreement contained in the City's RFQ package for Pavement Management System Updates; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with MDS Technologies, Inc., 350 S. Northwest Highway, Suite 300, Park Ridge, Illinois 60068, for Pavement Management System Updates.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 176 with MDS Technologies, Inc., 350 S. Northwest Highway, Suite 300, Park Ridge, Illinois 60068, for Pavement Management System Updates for a total amount not to exceed \$35,950; and that a copy of that certain City of Wheaton Agreement No. 176 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-07 and is hereby incorporated into this Resolution as if fully set forth herein.
