

**RESOLUTION R-2021-51**

**A RESOLUTION AUTHORIZING THE PURCHASE OF THERMOPLASTIC ROAD STRIPING SERVICES  
FROM SUPERIOR ROAD STRIPING, INC. THROUGH THE JOINT PURCHASING PROGRAM WITH  
THE SUBURBAN PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED  
\$35,235.30**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the City is a member of the Northwest Municipal Conference ("NWMC"), a corporate organization representing municipalities and townships located with the State of Illinois and Counties of Cook, DuPage, Kane, Lake and McHenry; and

**WHEREAS**, the City participates in the NWMC Suburban Purchasing Cooperative ("SPC"), which permits local governments to purchase commodities and services according to contracts negotiated by the NWMC, resulting in significant savings for the City; and

**WHEREAS**, the SPC joint purchasing program Contract #201 has been publicly and competitively bid for Thermoplastic Road Striping Services; and

**WHEREAS**, the SPC identified Superior Road Striping, Inc. located in Melrose Park, Illinois, as the low responsible bidder for SPC Contract #201; and

**WHEREAS**, the City budgeted funds in the General Fund in the amount of \$50,000.00; and

**WHEREAS**, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure Thermoplastic Road Striping Services from Superior Road Striping, Inc. in accordance with SPC Contract #201 in the unit price amounts of: \$3.75 per square foot for Thermoplastic Letters & Symbols, \$1.50 per linear foot for 12" lines, \$0.30 per square foot for Pavement Marking Removal (Grinding), \$0.75 per linear foot for 4" lines, and \$1.00 per linear foot for 6" lines, all in the total amount not-to-exceed \$32,235.30.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

**Section 1.** The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

**Section 2.** The City's Purchase Order #2022060 for Thermoplastic Road Striping Services through the Suburban Purchasing Cooperative Contract #201 with Superior Road

Striping, Inc., located in Melrose Park, Illinois, for a total amount not to exceed \$35,235.30 for the Street Division of the Public Works Department is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2022060 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-51 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Suburban Purchasing Cooperative agreement #201 is on file with the City Clerk's office as Exhibit A to Purchase Order #2022060 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
