

**RESOLUTION R-2021-86**

**A RESOLUTION AUTHORIZING THE SUBMISSION OF GRANT APPLICATIONS TO THE DUPAGE COUNTY COMMUNITY DEVELOPMENT COMMISSION FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR WATER MAIN PROJECTS**

**WHEREAS**, the City of Wheaton, as an entitlement area designated by the U.S. Department of Housing and Urban Development, elects to contribute its Community Development Block Grant (CDBG) funds to DuPage County to fund eligible housing projects and community improvements; and

**WHEREAS**, the City of Wheaton desires to submit an application to the DuPage County Community Development Commission to request CDBG funding through the Neighborhood Investment, Community-Wide Benefit, Accessibility Improvements, and Planning Projects grant program in the amount of six-hundred thousand (\$600,000) dollars for water main replacement in 2023 along Roosevelt Road between President Street and Blanchard Street; and

**WHEREAS**, the City of Wheaton desires to submit an application to the DuPage Community Development Commission to request funding through the Neighborhood Investment, Community-Wide Benefit, Accessibility Improvements, and Planning Projects grant program in the amount of six-hundred thousand (\$600,000) dollars for water main replacement in 2024 along Roosevelt Road between Blanchard Street and 1830 E. Roosevelt Road; and

**WHEREAS**, legislative action approving the submission of these applications and designating an official signatory to abide by the terms of any resulting grant agreement is a requirement of the DuPage County Neighborhood Investment grant program.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule authority, that:

Section 1. The foregoing recitals are incorporated into and made part of this Resolution.

Section 2. That the City Council does hereby authorize the submittal of the application for water main improvements along Roosevelt Road between President Street and Blanchard Street to request CDBG funding in the amount of six-hundred thousand (\$600,000) dollars to the DuPage County Community Development Commission.

Section 3. That the City Council does hereby authorize the submittal of the application for water main improvements along Roosevelt Road between Blanchard Street and 1830 E. Roosevelt Road to request CDBG funding in the amount of six-hundred thousand (\$600,000) dollars to the DuPage County Community Development Commission.

Section 4. That the City of Wheaton's Director of Finance or their designee are hereby authorized to submit the applications referenced in Section 2 and Section 3 of this resolution on behalf of the City to the DuPage County Development Commission.

Section 5. That if funding is awarded pursuant to the submitted applications referenced in Section 2 and Section 3 of this resolution, the City Council does hereby authorize the execution of a grant agreement with the County of DuPage for the projects ("Grant Agreement").

Section 6. That the Mayor is authorized to execute the Grant Agreement with the County of DuPage on behalf of the City.

Section 7. That City staff is directed and authorized to undertake any and all necessary acts to facilitate the effectuation of the Grant Agreement with the County of DuPage.
