

**RESOLUTION R-2021-88**

**A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) 2022 FORD F550 CHASSIS CAB FOR  
REPLACEMENT VEHICLE UNIT 7 FROM SUTTON FORD COMMERCIAL TRUCK CENTER THROUGH THE  
NORTHWEST MUNICIPAL CONFERENCE SUBURBAN PURCHASING COOPERATIVE FOR A TOTAL  
AMOUNT NOT TO EXCEED \$35,583**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the City is a member of the Northwest Municipal Conference (“NWMC”), a corporate organization representing municipalities and townships located with the State of Illinois and Counties of Cook, DuPage, Kane, Lake and McHenry; and

**WHEREAS**, the City participates in the NWMC Suburban Purchasing Cooperative (“SPC”), which permits local governments to purchase commodities and services according to contracts negotiated by the NWMC, resulting in significant savings for the City; and

**WHEREAS**, the SPC joint purchasing program Contract #178 has been publicly and competitively bid for vehicle and heavy equipment sales; and

**WHEREAS**, the SPC identified Sutton Ford Commercial Truck Center located in Matteson, Illinois, as the low responsible bidder for SPC Contract #178; and

**WHEREAS**, the City budgeted funds in the Vehicles account in the Fleet Services Fund for an amount of \$65,070; and

**WHEREAS**, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure one (1) 2022 Ford F550 Chassis Cab for replacement vehicle unit 7 from Sutton Ford Commercial Truck Center, 21315 Central Avenue, Matteson, Illinois 60443 in accordance with SPC contract #178 for a total amount not to exceed \$35,583.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

**Section 1.** The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

**Section 2.** The City's Purchase Order #2022091 for one (1) 2022 Ford F550 Chassis Cab through the Suburban Purchasing Cooperative Contract #178 with Sutton Ford Commercial Truck Center, located at 21315 Central Avenue, Matteson, Illinois, for a total amount not to exceed \$35,583 for the Street Division of the Public Works Department is hereby authorized (the “Purchase”).

A copy of the City's Purchase Order #2022091 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-88 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Suburban Purchasing Cooperative contract #178 is on

file with the City Clerk's office as Exhibit A to Purchase Order #2022091 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
