

RESOLUTION R-2021-89

**A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) FORD F550 DUMP TRUCK BODY FOR
REPLACEMENT VEHICLE UNIT 7 FROM HENDERSON PRODUCTS THROUGH THE SOURCEWELL
PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$35,073**

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, Sourcewell is a state of Minnesota local government unit and service cooperative purchasing program created by the Minnesota legislature under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

WHEREAS, the City is a member of the Sourcewell cooperative purchasing program, which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

WHEREAS, Sourcewell contract #080818-HPI has been publicly and competitively bid for heavy duty work trucks, upfitting of multi-purpose equipment and supplies; and

WHEREAS, Sourcewell has identified Henderson Products located in Huntley, Illinois, as the low responsible bidder for Sourcewell contract #080818-HPI; and

WHEREAS, the City budgeted funds in the Vehicles account in the Fleet Services Fund for an amount of \$65,070; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure one (1) Ford F550 Dump Truck Body for replacement vehicle unit 7 from Henderson Products, 11921 Smith Drive, Huntley, Illinois 60142 in accordance with Sourcewell contract #080818-HPI for a total amount not to exceed \$35,073.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2022089 for one (1) Ford F550 Dump Truck Body through Sourcewell Cooperative Contract #080818-HPI with Henderson Products, located at 11921 Smith Drive, Huntley, Illinois, for a total amount not to exceed \$35,073 for the Street Division of the Public Works Department is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2022089 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-89 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Sourcewell cooperative contract #080818-HPI is on file with the City Clerk's office as Exhibit A to Purchase Order #2022089 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
