

RESOLUTION R-2021-93

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 235 WITH
ENGINEERING RESOURCE ASSOCIATES, INC. FOR FINAL ENGINEERING SERVICES FOR THE DORSET
DRIVE FLOOD IMPROVEMENTS FOR A TOTAL AMOUNT NOT TO EXCEED \$29,120**

WHEREAS, the City prepared a Request for Proposal package (RFP Number 21-130) for final professional engineering services for the Dorset Drive Flood Improvements; and

WHEREAS, Engineering Resource Associates, Inc. submitted a proposal to provide final professional engineering services for the Dorset Drive flood improvements in the amount of \$29,120; and

WHEREAS, it was determined by the City that the Engineering Resource Associates, Inc. proposal meets the City's needs; and

WHEREAS, the City has sufficient reserve funds available in the Capital Projects Fund to accommodate the cost of the Dorset Drive Flood Improvements as proposed by Engineering Resource Associates, Inc.; and


WHEREAS, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for final professional engineering services for the Dorset Drive Flood Improvements; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Engineering Resource Associates, Inc., 3S701 West Avenue, Suite 150, Warrenville, Illinois, 60555, for professional engineering services for the Dorset Drive Flood Improvements.

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 235 with Engineering Resource Associates, Inc., 3S701 West Avenue, Suite 150, Warrenville, Illinois, 60555, for final professional engineering services for the Dorset Drive Flood Improvements for a total amount not to exceed \$29,120; and that a copy of that certain City of Wheaton Agreement No. 235 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-93 and is hereby incorporated into this Resolution as if fully set forth herein.
