

RESOLUTION R-2021-106

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 256 WITH  
CHICAGOLAND PAVING CONTRACTORS, INC., FOR HOT MIX ASPHALT SURFACE REMOVAL SERVICES  
FOR A TOTAL AMOUNT NOT TO EXCEED \$60,000**

**WHEREAS**, the City prepared a bid package (Bid Number 22-10) that included Hot Mix Asphalt Surface Removal Services; and

**WHEREAS**, the City solicited bids in a public bidding process and bids were publicly opened and read on November 23, 2021, at 11:00 AM. Chicagoland Paving Contractors, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$60,000. This is a one (1) year agreement with the City's option to extend the agreement at the same prices and terms for two (2) additional one-year terms; and

**WHEREAS**, the City budgeted funds in the CY2022 General Fund in the amount of \$60,000 for Hot Mix Asphalt Surface Removal Services; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Hot Mix Asphalt Surface Removal Services; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Chicagoland Paving Contractors, Inc., located at 225 Telser Rd., Lake Zurich, Illinois, 60047, for Hot Mix Asphalt Surface Removal Services.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 256 with Chicagoland Paving Contractors, Inc., located at 225 Telser Rd., Lake Zurich, Illinois, 60047, for Hot Mix Asphalt Surface Removal Services for a one (1) year term and a total amount not to exceed \$60,000, with the City's option to extend the agreement at the same prices and terms for two (2) additional one-year terms; and that a copy of that certain City of Wheaton Agreement No. 256 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-106 and is hereby incorporated into this Resolution as if fully set forth herein.
