

RESOLUTION R-2021-107

A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 252 WITH STRAND ASSOCIATES, INC. FOR PROFESSIONAL ENGINEERING SERVICES FOR THE CREEKSIDER DRIVE BRIDGE REPLACEMENT FOR A TOTAL AMOUNT NOT TO EXCEED \$130,768

WHEREAS, the City prepared a Request for Proposal (RFP) package (RFP Number 21-141) for Professional Engineering Services for the Creekside Drive Bridge Replacement; and

WHEREAS, Strand Associates, Inc. submitted a proposal to provide professional engineering services in the amount of \$130,768; and

WHEREAS, staff reviewed proposals, and it was determined that the proposal from Strand Associates, Inc. meets the City's needs; and

WHEREAS, this project was originally scheduled as a repair; therefore, only \$25,000 was budgeted for professional engineering services in the 2022 budget. The Capital Projects Fund has the reserves available to accommodate the additional cost; and

WHEREAS, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Professional Engineering Services for the Creekside Drive Bridge Replacement; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Strand Associates, Inc. located at 910 West Wingra Drive, Madison, WI 53715, for Professional Engineering Services for the Creekside Drive Bridge Replacement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to the City of Wheaton Agreement No. 252 with Strand Associates, Inc., located at 910 West Wingra Drive, Madison, WI 53715, for Professional Engineering Services for the Creekside Drive Bridge Replacement for a total amount not to exceed \$130,768; and that a copy of that certain City of Wheaton Agreement No. 252 is on file with the City Clerk's office as Exhibit A to this Resolution R-2021-107 and is hereby incorporated into this Resolution as if fully set forth herein.
