

**ORDINANCE NO. 0-2021-53**

**AN ORDINANCE OF THE CITY OF WHEATON, ILLINOIS  
TERMINATING SPECIAL SERVICE AREA NO. 2  
(CENTRAL BUSINESS DISTRICT)**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, an ordinance establishing Special Service Area No. 2 (Central Business District) (hereinafter, "SSA #2") was adopted on February 8, 1983 by Ordinance No. E-1914 to provide no-fee one hour and two hour customer parking at certain locations within the City's Central Business District, special services in addition to services provided to the City generally; and

**WHEREAS**, the City Council has determined it is necessary and in the best interests of the City to terminate SSA #2.

**NOW THEREFORE, BE IT ORDAINED** by the City Council of the City of Wheaton, DuPage County, Illinois, as follows:

**Section 1:** Ordinance No. E-1914, being "An Ordinance Establishing City of Wheaton Special Service Area No. 2 (Central Business District)," is hereby repealed and rescinded in its entirety.

**Section 2:** SSA #2, shall be fully terminated for all purposes and no further taxes shall be levied and extended as of the effective date of this Ordinance.

**Section 3:** To comply with Section 27-93 of the Property Tax Code, the City has determined that no excess revenues exist in SSA #2 as all SSA #2 funds have been spent. Therefore, no SSA #2 taxpayer refunds are necessary.

**Section 4:** The City Clerk or designee is hereby authorized and directed to record a copy of this Ordinance terminating SSA #2 with the office of the DuPage County Recorder and file a copy of this Ordinance with the DuPage County Clerk's office.

**Section 5:** All ordinances or parts of ordinances in conflict with these provisions are repealed.

**Section 6:** This Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner prescribed by law.
