

RESOLUTION R-2022-01

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 261 WITH  
COMCAST BUSINESS FOR ENTERPRISE NETWORK SERVICES FOR A THREE (3) YEAR TERM AND  
A TOTAL AMOUNT NOT TO EXCEED \$113,400 (\$37,800 ANNUALLY)**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City has an existing agreement with Comcast Business for Enterprise Network Services that will expire January 17,2022; and

**WHEREAS**, Comcast Business submitted a proposal for the renewal of Enterprise Network Services for a three (3) year term and a total amount not to exceed \$113,400; and

**WHEREAS**, the City budgeted funds in CY2022 in multiple accounts for Enterprise Network Services in the amount of \$50,292; and

**WHEREAS**, both parties agree to the terms and conditions set forth in Agreement No. 261 for Enterprise Network Services; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Comcast Business for Enterprise Network Services.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 261 with Comcast Business located at PO Box 37601 Philadelphia, Pennsylvania, 19101, for Enterprise Network Services for a three (3) year term and a total amount not to exceed \$113,400; and that a copy of that certain City of Wheaton Agreement No. 261 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-01 and is hereby incorporated into this Resolution as if fully set forth herein.
