

**RESOLUTION R-2022-05**

**A RESOLUTION AUTHORIZING THE RENTAL OF ONE (1) BACKHOE LOADER AND ONE (1) DUMP TRUCK FROM HERC RENTALS, INC. THROUGH THE OMNIA PARTNERS COOPERATIVE PURCHASING PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$40,000**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase and rent supplies; and

**WHEREAS**, the City is a member of OMNIA Partners ("OMNIA"), a corporate organization located in Franklin, TN representing state and local government, K-12 education, colleges, and universities worldwide; and

**WHEREAS**, The City participates in the OMNIA Partners Cooperative Purchasing Program which permits local governments to purchase commodities and services according to contracts negotiated by OMNIA, resulting in significant savings for the City; and

**WHEREAS**, Omnia Partners Cooperative Purchasing Program cooperative contract #2019000318 has been publicly and competitively bid for heavy equipment rentals; and

**WHEREAS**, Omnia Partners has identified Herc Rentals, Inc. located in Chicago, Illinois as the low responsible bidder for Omnia cooperative contract #2019000318; and


**WHEREAS**, the City budgeted funds in the CY2022 Storm Sewer Fund for an amount of \$40,000; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to rent one (1) Backhoe Loader and one (1) Dump Truck, for the Sewer Division of the Public Works Department, from Herc Rentals, Inc. located at 4039 South Peoria Street, Chicago, Illinois, 60609 in accordance with Omnia Partners cooperative contract #2019000318 for a total amount not to exceed \$30,208, with the option to extend the term on either a daily, weekly, or monthly basis for up to an additional six (6) months.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 262 with Herc Rentals, Inc., 4039 South Peoria Street, Chicago, Illinois, 60609 for the rental of one (1) Backhoe Loader and one (1) Dump Truck, for the Sewer Division of the Public Works Department, through the Omnia Partners cooperative contract #2019000318 for a total amount not to exceed \$40,000, with the option to extend the term on either a daily, weekly, or monthly basis for up to an additional six (6) months; and that City staff is directed to undertake any and all other tasks necessary, or in furtherance of, completion of the rental transaction. A copy of the certain City of Wheaton Agreement No. 262 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-05 and is hereby incorporated into this Resolution as if fully set forth herein; and a copy of the Omnia Partners cooperative contract #2019000318 is on file with the City Clerk's office as Exhibit A-1 to City of Wheaton Agreement No. 262 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.
