

RESOLUTION R-2022-06

**A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) LARGE DIAMETER SEWER CAMERA AND VEHICLE UNIT FROM STANDARD EQUIPMENT THROUGH THE HOUSTON-GALVESTON AREA COUNCIL COOPERATIVE PURCHASING PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$324,737.17**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the Houston-Galveston Area Council ("H-GAC") is a council of governments comprised of a region wide voluntary association of local governments in the State of Texas operating under Chapter 391 of the Texas Local Government Code and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

**WHEREAS**, the H-GAC is a political subdivision of the State of Texas; and

**WHEREAS**, the H-GAC Cooperative Purchasing Program (HGACBuy) establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

**WHEREAS**, the City is a member of H-GACBuy; and

**WHEREAS**, H-GACBuy cooperative contract #SC01-21A has been publicly and competitively bid for sewer inspection equipment; and

**WHEREAS**, H-GAC has identified EnviroSight, LLC. as the low responsible bidder for H-GACBuy cooperative contract #SC01-21A; and

**WHEREAS**, EnviroSight, LLC. only sells through its authorized dealers; and

**WHEREAS**, Standard Equipment located in Elmhurst, Illinois, has been identified as the only authorized dealer for our territory; and

**WHEREAS**, the City budgeted funds in the CY2022 Sanitary Sewer Fund for an amount of \$325,000.00; and

**WHEREAS**, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure one (1) Large Diameter Sewer Camera and Vehicle Unit, for the Sewer Division of the Public Works Department, from EnviroSight, LLC. through its authorized dealer Standard Equipment located at 625 S. IL Route 83, Elmhurst, Illinois, 60126 in accordance with H-GACBuy cooperative contract #SC01-21A, for a total amount not to exceed \$324,737.17.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2023013 for one (1) Large Diameter Sewer Camera and Vehicle Unit, for the Sewer Division of the Public Works Department, from EnviroSight, LLC. through its authorized dealer Standard Equipment located at 625 S. IL Route 83, Elmhurst, Illinois, 60126 in accordance with the H-GACBuy cooperative contract #SC01-21A, for a total amount not to exceed \$324,737.17, is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2023013 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-06 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the H-GACBuy cooperative contract #SC01-21A is on file with the City Clerk's office as Exhibit A to Purchase Order #2023013 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
