

RESOLUTION R-2022-10

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) 2022 PAVEMENT ROLLER FROM WEST SIDE TRACTOR SALES THROUGH THE SOURCEWELL COOPERATIVE PURCHASING PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$64,214

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, Sourcewell is a state of Minnesota local government unit and service cooperative purchasing program created by the Minnesota legislature under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

WHEREAS, the City participates in the Sourcewell cooperative purchasing program, which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

WHEREAS, Sourcewell cooperative contract #032119-BAI has been publicly and competitively bid for heavy construction equipment with related accessories, attachments, and supplies; and

WHEREAS, Sourcewell has identified Bomag Americas, Inc. as the low responsible bidder for Sourcewell cooperative contract #032119-BAI; and

WHEREAS, Bomag Americas, Inc. only sells through its authorized dealers; and

WHEREAS, West Side Tractor Sales located in Wauconda, Illinois, has been identified as the only authorized dealer for our territory; and

WHEREAS, the City budgeted funds in the CY2022 Vehicles account in the Fleet Services Fund for an amount of \$64,247; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure one (1) 2022 Pavement Roller, for the Street Division of the Public Works Department, from Bomag Americas, Inc. through its authorized dealer West Side Tractor Sales located at 1560 N. Old Rand Road, Wauconda, Illinois, 60084 in accordance with Sourcewell cooperative contract #032119-BAI for a total amount not to exceed \$64,214.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:


Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2023017 for one (1) 2022 Pavement Roller, for the Sewer Division of the Public Works Department, from Bomag Americas, Inc. through its authorized dealer West Side Tractor Sales located at 1560 N. Old Rand Road, Wauconda, Illinois, 60084 in accordance with Sourcewell cooperative contract #032119-BAI for a total amount not to exceed \$64,214 is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2023017 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-10 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Sourcewell cooperative contract #032119-BA1 is on file with the City Clerk's office as Exhibit A-1 to Purchase Order #2023017 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
