

RESOLUTION R-2022-11

A RESOLUTION AUTHORIZING THE PURCHASE OF THREE (3) 2022 FORD ESCAPE SE HYBRID VEHICLES FROM CURRIE MOTORS FLEET THROUGH THE NORTHWEST MUNICIPAL CONFERENCE SUBURBAN PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$73,461

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the City is a member of the Northwest Municipal Conference (“NWMC”), a corporate organization representing municipalities and townships located with the State of Illinois and Counties of Cook, DuPage, Kane, Lake and McHenry; and

WHEREAS, the City participates in the NWMC Suburban Purchasing Cooperative (“SPC”), which permits local governments to purchase commodities and services according to contracts negotiated by the NWMC, resulting in significant savings for the City; and

WHEREAS, SPC cooperative contract #206 has been publicly and competitively bid for vehicle and heavy equipment sales; and

WHEREAS, SPC has identified Currie Motors Fleet located in Frankfort, Illinois, as the low responsible bidder for SPC cooperative contract #206; and

WHEREAS, the City budgeted funds in the CY2022 Vehicles account in the Fleet Services Fund for an amount of \$65,070 and the Fleet Services Fund has the reserves available to accommodate the additional cost; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure three (3) 2022 Ford Escape SE Hybrid vehicles, for the Public Works and Engineering Departments, from Currie Motors Fleet located at 21315 Central Avenue, Frankfort, Illinois, 60443 in accordance with SPC cooperative contract #206 for a total amount not to exceed \$73,461.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City’s Purchase Order #2023016 for three (3) 2022 Ford Escape SE Hybrid vehicles, for the Public Works and Engineering Departments, from Currie Motors Fleet located at 21315 Central Avenue, Frankfort, Illinois, 60443 in accordance with SPC cooperative contract #206 for a total amount not to exceed \$73,461 is hereby authorized (the “Purchase”).

A copy of the City’s Purchase Order #2023016 is on file with the City Clerk’s office as Exhibit A to this Resolution R-2022-11 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Suburban Purchasing Cooperative contract #206 is on

file with the City Clerk's office as Exhibit A to Purchase Order #2023016 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
