

RESOLUTION R-2022-14

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 274 WITH  
BME ELECTRIC, INC. FOR ELECTRICAL SERVICES FOR A TECHNOLOGY UPGRADE AT CITY HALL FOR A TOTAL  
AMOUNT NOT TO EXCEED \$18,747**

**WHEREAS**, the City solicited bid package (Bid Number 21-156) that included Electrical Services for a Technology Upgrade at City Hall; and

**WHEREAS**, the City solicited bids in a public bidding process and bids were publicly opened and read on December 13, 2021, at 11:00 AM. BME Electrical, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$18,747; and

**WHEREAS**, the City budgeted \$122,424 in the Building Renewal Fund for an Audio-Visual Equipment and Installation Upgrade at City Hall; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Electrical Services for a Technology Upgrade at City Hall; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with BME Electrical, Inc. located at 9935 S. 76<sup>th</sup> Avenue, Unit A, Bridgeview, Illinois 60455, for Electrical Services for a Technology Upgrade at City Hall.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 274 with BME Electrical, Inc. located at 9935 S. 76<sup>th</sup> Avenue, Unit A, Bridgeview, Illinois 60455, for Electrical Services for a Technology Upgrade at City Hall; and that a copy of that certain City of Wheaton Agreement No. 274 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-14 and is hereby incorporated into this Resolution as if fully set forth herein.
