

RESOLUTION R-2022-17

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 278 WITH
SCHROEDER & SCHROEDER, INC. FOR THE 2022 SPRING NEW SIDEWALK PROGRAM
FOR A TOTAL AMOUNT NOT TO EXCEED \$570,826.65**

WHEREAS, the City solicited an Invitation to Bid (Bid Number 22-39) for the 2022 Spring New Sidewalk Program; and

WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on February 23, 2022, at 10:00 AM. Schroeder & Schroeder, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$570,826.65; and

WHEREAS, the City budgeted funds in the CY2022 Capital Projects Fund in an amount of \$1,170,000 for the 2022 Spring and Fall New Sidewalk Program; and

WHEREAS, the City has received \$2.5 million to date from the American Rescue Plan Act (ARPA), of which \$820,000 will be allocated to fund the 2022 Spring and Fall New Sidewalk Program; and


WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for the 2022 Spring New Sidewalk Program; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Schroeder & Schroeder, Inc., 7306 Central Park, Skokie, Illinois, 60076, for the 2022 Spring New Sidewalk Program.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 278 with Schroeder & Schroeder, Inc., 7306 Central Park, Skokie, Illinois, 60076, for the 2022 Spring New Sidewalk Program for a total amount not to exceed \$570,826.65; and that a copy of that certain City of Wheaton Agreement No. 278 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-17 and is hereby incorporated into this Resolution as if fully set forth herein.
