

RESOLUTION R-2022-29

A RESOLUTION AUTHORIZING THE PURCHASE OF CRACK SEALING AND SEAL COATING SERVICES FROM SKC CONSTRUCTION, INC. THROUGH THE JOINT PURCHASING PROGRAM WITH THE VILLAGE OF WOODRIDGE FOR A TOTAL AMOUNT NOT TO EXCEED \$85,150

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the City participated in a joint purchasing solicitation (Bid Number 22-07) lead by the Village of Woodridge, which included a total of nine (9) communities, for Crack Sealing and Seal Coating Services; and

WHEREAS, the Village of Woodridge ("Village") solicited bids in a public bidding process and bids were publicly opened and read on February 1, 2022, at 11:00 AM and SKC Construction, Inc. was determined to be the lowest, responsive, responsible bidder; and

WHEREAS, the City budgeted funds in the CY2022 General Fund for a total amount of \$85,150 for Crack Sealing and Seal Coating Services; and

WHEREAS, both parties agree to the terms and conditions and pricing set forth in the bid proposal and the agreement for Crack Sealing and Seal Coating Services; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with SKC Construction, Inc., 695 Church Road, Elgin, Illinois, 60123, for the purchase of Crack Sealing and Seal Coating Services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 283 with SKC Construction, Inc., 695 Church Road, Elgin, Illinois, 60123, for Crack Sealing and Seal Coating Services for a one (1) year term and a total amount not to exceed \$85,150, with the City's option to extend the agreement at the agreed upon prices and terms of the original agreement for two (2) additional one-year terms; and that a copy of that certain City of Wheaton Agreement No. 283 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-29 and is hereby incorporated into this Resolution as if fully set forth herein.
