

RESOLUTION R-2022-34

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) JOHN DEERE BACKHOE LOADER FOR REPLACEMENT VEHICLE UNIT 166 FROM WEST SIDE TRACTOR SALES THROUGH THE SOURCEWELL PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$126,974.12

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, Sourcewell is a state of Minnesota local government unit and service cooperative purchasing program created by the Minnesota legislature under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

WHEREAS, the City is a member of the Sourcewell cooperative purchasing program, which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

WHEREAS, Sourcewell contract #032119-JDC has been publicly and competitively bid for heavy construction equipment and supplies, including backhoe loaders; and

WHEREAS, Sourcewell has identified West Side Tractor Sales as the low responsible bidder for Sourcewell cooperative contract #032119-JDC; and

WHEREAS, the City budgeted funds in the Vehicles account in the Fleet Services Fund for an amount of \$113,300 for a replacement Backhoe Loader; and

WHEREAS, the replacement Backhoe Loader costs \$126,974.12 under Sourcewell cooperative contract #032119-JDC; and

WHEREAS, West Side Tractor Sales has offered to provide the City with a trade-in amount of \$20,000.00 for a 2007 model year Backhoe Loader that may be applied against and reduce the cost of the replacement Backhoe Loader purchase; and

WHEREAS with the \$20,000 trade-in value applied, the cost of the replacement Backhoe Loader is \$106,974.12, which is \$6,325.88 under budget; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to trade-in the 2007 model year Backhoe Loader and procure one (1) John Deere 310SL Backhoe Loader for replacement vehicle Unit 166 from West Side Tractor Sales, located at 1560 N. Old Rand Road, Wauconda, Illinois, 60084 in accordance with Sourcewell cooperative contract #032119-JDC for a total amount not to exceed \$126,974.12.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2023031 for one (1) John Deere 310SL Backhoe Loader through Sourcewell cooperative contract #032119-JDC with West Side Tractor Sales, located in Wauconda, Illinois, 60084, for a total amount not to exceed \$126,974.12, with the \$20,000.00 trade-in value for the trade-in of the 2007 model year Backhoe Loader being applied as an offset against this total cost, is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2023031 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-34 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Sourcewell cooperative contract #032119-JDC is on file with the City Clerk's office as Exhibit A to Purchase Order #2023031 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.


Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
