

RESOLUTION R-2022-35

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 291 WITH
MUSCAT PAINTING & DECORATING FOR FIRE HYDRANT SANDBLASTING AND PAINTING SERVICES
FOR A THREE (3) YEAR TERM AND A TOTAL AMOUNT NOT TO EXCEED \$74,807.50**

WHEREAS, the City prepared a bid package (Bid Number 22-74) that included Fire Hydrant Sandblasting and Painting Services; and

WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on April 13, 2022, at 11:00 AM. Muscat Painting and Decorating was determined to be the lowest, responsive, responsible bidder with a bid amount of \$74,807.50 for a three-year term (\$24,445.00 for year 1, \$24,932.50 for year 2, and \$25,430.00 for year 3); and

WHEREAS, the City budgeted funds in the CY2022 Water fund in an amount of \$22,000 for Fire Hydrant Sandblasting and Painting Services and the Water fund has the reserves available to accommodate the additional cost; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Fire Hydrant Sandblasting and Painting Services; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Muscat Painting & Decorating, 555 Ashland Avenue, East Dundee, Illinois, 60118, for Fire Hydrant Sandblasting and Painting Services.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 291 with Muscat Painting & Decorating for Fire Hydrant Sandblasting and Painting Services for a three (3) year term and a total amount not to exceed \$74,807.50 (\$24,445.00 for year 1, \$24,932.50 for year 2, \$25,430.00 for year 3); and that a copy of that certain City of Wheaton Agreement No. 291 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-35 and is hereby incorporated into this Resolution as if fully set forth herein.
