

RESOLUTION R-2022-38

**A RESOLUTION AUTHORIZING THE PURCHASE OF BULK ROCK SALT FROM MORTON SALT, INC.
THROUGH THE JOINT PURCHASING PROGRAM WITH DUPAGE COUNTY FOR A
TOTAL AMOUNT OF \$267,730**

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the City participated in a joint purchasing solicitation (Bid Number 22-044-DOT) led by DuPage County, which included a total of 37 surrounding communities, for Bulk Rock Salt; and

WHEREAS, DuPage County ("County") solicited bids in a public bidding process and bids were publicly opened and read on April 27, 2022, at 2:00 PM and Morton Salt, Inc. was determined to be the lowest, responsive, responsible bidder with a bid in the amount of \$75.88 per ton for standard delivery up to 130% of projected usage and a unit cost of \$85.88 per ton for 131% to 150% of projected usage (hereinafter "Joint Purchase Pricing"); and

WHEREAS, the City requested 2,000 tons of bulk rock salt through the joint purchase and is required to purchase 1600 tons (80% of the 2,000 ton order) of rock salt and can receive up to 2600 tons (130% of the 2,000 ton order) of rock salt for the price of \$75.88 per ton; and

WHEREAS, the City budgeted funds in the CY2022 General Fund for a total amount of \$267,730 for Bulk Rock Salt; and

WHEREAS, both parties agree to the terms and conditions and pricing set forth in the bid proposal and the agreement for Bulk Rock Salt; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Morton Salt, Inc., 444 West Lake Street, Chicago, Illinois, 60606, for the purchase of Bulk Rock Salt on an as needed basis, in accordance with the Joint Purchase Pricing, with a minimum purchase of 1,600 tons and for a period of one (1) year, with the option to extend for three (3) additional one-year terms.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 294 with Morton Salt, Inc., 444 West Lake Street, Chicago, Illinois, 60606, for the purchase of Bulk Rock Salt on an as needed basis in accordance with the pricing in DuPage County Bid Number 22-044 DOT for a one (1) year term and a total amount of \$267,730 with the City's option to extend the agreement at the agreed upon prices and terms of the original agreement for three (3) additional one-year terms; and that a copy of that certain City of Wheaton Agreement No. 294 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-38 and is hereby incorporated into this Resolution as if fully set forth herein.
