

RESOLUTION R-2022-40

A RESOLUTION AUTHORIZING THE PURCHASE OF NINE (9) ROOFTOP HVAC UNITS FOR THE PUBLIC WORKS FACILITY FROM TRANE TECHNOLOGIES THROUGH THE OMNIA PARTNERS COOPERATIVE PURCHASING PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$68,503

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase and rent supplies; and

WHEREAS, the City is a member of OMNIA Partners ("OMNIA"), a corporate organization located in Franklin, TN representing state and local government, K-12 education, colleges, and universities worldwide; and

WHEREAS, the City participates in the OMNIA Partners Cooperative Purchasing Program which permits local governments to purchase commodities and services according to contracts negotiated by OMNIA, resulting in significant savings for the City; and

WHEREAS, Omnia Partners Cooperative Purchasing Program cooperative contract #15-JLP-023 has been publicly and competitively bid for HVAC Equipment; and

WHEREAS, Omnia Partners has identified Trane Technologies located in Davidson, North Carolina as the low responsible bidder for Omnia cooperative contract #15-JLP-023; and

WHEREAS, the City budgeted funds in the CY2022 Building Renewal Fund for an amount of \$105,000 for the Public Works Rooftop HVAC Unit Replacement Project; and

WHEREAS, the corporate authorities of the City of Wheaton find it reasonable and appropriate to purchase nine (9) Rooftop HVAC Units for the Public Works facility from Trane Technologies located at 800 E. Beatty Street, Davidson, North Carolina, 28036, in accordance with Omnia Partners cooperative contract #15-JLP-023 for a total amount not to exceed \$68,503.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:


Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2023034 for nine (9) Rooftop HVAC Units for the Public Works facility from Trane Technologies located at 800 E. Beatty Street, Davidson, North Carolina, 28036, in accordance with Omnia cooperative contract #15-JLP-023 for a total amount not to exceed \$68,503 is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2023034 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-40 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and a copy of the Omnia cooperative contract #15-JLP-023 is on file with the City Clerk's office as Exhibit A to Purchase Order #2023034 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
