

RESOLUTION R-2022-48

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 301 WITH
ELLEVATE CONSULTING, LLC TO DEVELOP A STRATEGIC PLAN OF ACTION FOR ECONOMIC
DEVELOPMENT FOR A TOTAL AMOUNT NOT TO EXCEED \$5,000**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, staff received and presented a proposal to the City Council from Ellevate Consulting, LLC to provide City-wide Marketing, Economic Development and Special Event Management Services; and

WHEREAS, the City Council directed staff to further discuss and develop an agreement with Ellevate Consulting, LLC for these services; and


WHEREAS, both parties agreed it would be beneficial to proceed with consulting services to develop a Strategic Plan of Action for Economic Development to help detail the expectations for services supporting future economic development efforts for a total amount not to exceed \$5,000 and the terms and conditions set forth in City Agreement No. 301; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Ellevate Consulting, LLC located at 605 E. Galena Blvd, Aurora, Illinois 60505 to develop a Strategic Plan of Action for Economic Development.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 301 with Ellevate Consulting, LLC located at 605 E. Galena Blvd, Aurora, Illinois 60505, to develop a Strategic Plan of Action for Economic Development for a total amount not to exceed \$5,000; and that a copy of that certain City of Wheaton Agreement No. 301 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-48 and is hereby incorporated into this Resolution as if fully set forth herein.
