

RESOLUTION R-2022-47

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 305 WITH
THOMAS ENGINEERING GROUP, LLC. FOR PROFESSIONAL ENGINEERING SERVICES FOR PHASE I AND
PHASE II OF THE LAFO RESURFACING PROJECT-LORRAINE ROAD BETWEEN HARWARDEN STREET AND
ROUTE 38 FOR A TOTAL AMOUNT NOT TO EXCEED \$51,844.84**

WHEREAS, the City prepared a Request for Proposal package (RFP Number 22-109) Professional Engineering Services for; and

WHEREAS, Thomas Engineering Group, LLC. submitted a proposal to provide Professional Engineering Services for Phase I and II of the LAFO Resurfacing Project - Lorraine Road between Harwarden Street and Route 38 in the amount of \$51,844.24; and

WHEREAS, it was determined by the City that the proposal submitted by Thomas Engineering Group, LLC. meets the City's needs; and

WHEREAS, this project was not included in the CY2022 budget, however, the Capital Project Fund has the reserves available to accommodate the additional cost; and

WHEREAS, both parties agree to the terms and conditions set forth in the RFP and the agreement contained in the City's RFP package for Professional Engineering Services for Phase I and II of the LAFO Resurfacing Project - Lorraine Road between Harwarden Street and Route 38; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Thomas Engineering Group, LLC., located at 762 Shoreline Drive, Suite 200, Aurora, Illinois, 60504, for Professional Engineering Services for Phase I and II of the LAFO Resurfacing Project - Lorraine Road between Harwarden Street and Route 38.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 305 with Thomas Engineering Group, LLC., located at 762 Shoreline Drive, Suite 200, Aurora, Illinois, 60504, for Professional Engineering Services for Phase I and II of the LAFO Resurfacing Project - Lorraine Road between Harwarden Street and Route 38 for a total amount not to exceed \$51,844.24; and that a copy of that certain City of Wheaton Agreement No. 305 is on file with the City Clerk's office as Exhibit A to this Resolution R-2022-47 and is hereby incorporated into this Resolution as if fully set forth herein.
