

RESOLUTION R-2022-51
A RESOLUTION FOR THE IMPROVEMENT
UNDER THE ILLINOIS HIGHWAY CODE
(2022 ROAD, SEWER, AND WATER REHABILITATION PROGRAM)

BE IT RESOLVED, by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets be improved under the Illinois Highway Code (street listing attached as Exhibit A). Work shall be done by Contract.

BE IT FURTHER RESOLVED,

1. That the proposed improvement shall consist of approximately 123,758 SY of pavement overlay including spot curb & gutter, concrete road panel replacement, drive approach & sidewalk removal & replacement, pavement milling, leveling binder, area reflective crack control treatment, & surface course; 7,100 SY of reconstruction including pavement & base removal, aggregate & HMA base reconstruction, binder, & surface course; curb & gutter drive approach & sidewalk removal & replacement; storm & sanitary structure replacement; sanitary sewer replacement; water main replacement; & landscaping along various streets in the City of Wheaton.; and shall be designated as Section 22-00126-00-FP.
2. That there is hereby appropriated the sum of TWO MILLION, FIVE HUNDRED FORTY-SEVEN THOUSAND, FOUR HUNDRED TWENTY-NINE AND 31/100 DOLLARS (\$2,547,429.31) for the improvement of said section from the Local Public Agency's allotment of Motor Fuel Tax funds.
3. That there is hereby appropriated the sum of NINE HUNDRED FORTY-NINE THOUSAND, FIVE HUNDRED FORTY AND 60/100 DOLLARS (\$949,540.60) for the improvement of said section from Rebuild Illinois Bond Fund.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit four (4) certified copies of this resolution to the district office of the Illinois Department of Transportation.
