

**ORDINANCE NO. O-2022-37**

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR VEHICLE  
AND TRAFFIC SCHEDULES (CHAPTER 70)  
FOR THE CITY OF WHEATON**

**BE IT ORDAINED** by the Mayor and City Council of the City of Wheaton, Illinois as follows:

**SECTION 1:** That the Official Motor Vehicle and Traffic Schedule X-D, Leased Parking (Sec. 70-413) of the Wheaton City Code, 2017, as amended, is hereby amended as such:

Paragraphs (9) and (10) are hereby repealed in their entirety and replaced with the following:

“(9) Municipal Parking Garage North (Wheaton Place Garage at Wheaton Avenue between Wesley Street and Front Street), leased parking spaces are available on floors 3 and 4, Monday through Sunday, to persons residing in a dwelling (Residential Lease) located in the area within the City of Wheaton bounded by West Street on the west, Seminary Avenue on the north, Washington Street on the east and Illinois Street on the south, hereinafter referred to as the “Boundary,” and their guests (Condo Guest Parking), and on floors 3 and 4, Monday through Friday, to persons who own, operate, manage, or are employed at a place of business (Commercial Lease) located within the Boundary. Daily fee parking spaces are available on the top floor, Monday through Friday. To maximize the number of parking spaces available to the public in the evenings during the week and on weekends, leased parking at Municipal Parking Garage North is available exclusively to leaseholders Monday through Friday, 8:00 a.m. to 3:00 p.m., after which time parking is free and open to the public based on availability.

(10) Municipal Parking Garage South (Willow Avenue Garage at Willow Avenue and Cross Street), leased parking spaces are available on floors 2, 3, and 4, Monday through Sunday, to persons residing in a dwelling (Residential Lease) located in the area within the City of Wheaton bounded by West Street on the west, Seminary Avenue on the north, Washington Street on the east and Illinois Street on the south, hereinafter referred to as the “Boundary,” and on floors 2, 3 and 4, Monday through Friday, to persons who own, operate, manage, or are employed at a place of business (Commercial Lease) located within the Boundary. To maximize the number of parking spaces available to the public in the evenings during the week and on weekends, leased parking at Municipal Parking Garage South is available exclusively to leaseholders Monday through Friday, 8:00 a.m. to 3:00 p.m., after which time parking is free and open to the public based on availability.

**SECTION 2:** That all ordinances or parts of ordinances in conflict with provisions of this Ordinance are hereby repealed.

**SECTION 3:** That this Ordinance shall become effective from and after its passage, approval, and publication provided by law.
