

RESOLUTION R-2023-05

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) REPLACEMENT ASPHALT PATCHING TRAILER FROM SPAULDING MANUFACTURING, INC. IN ACCORDANCE WITH THE HOUSTON-GALVESTON AREA COUNCIL COOPERATIVE PURCHASING PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$32,810

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the Houston-Galveston Area Council ("H-GAC") is a council of governments comprised of a region wide voluntary association of local governments in the State of Texas operating under Chapter 391 of the Texas Local Government Code and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

WHEREAS, the H-GAC is a political subdivision of the State of Texas; and

WHEREAS, the H-GAC operates the H-GAC Cooperative Purchasing Program (HGACBuy) which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

WHEREAS, the City is a member of H-GACBuy; and

WHEREAS, the H-GACBuy contract #SM10-20 has been publicly and competitively bid for street maintenance equipment; and

WHEREAS, Spaulding Manufacturing, Inc. has been identified as the low responsible bidder for HGACBuy cooperative contract #SM10-20 for street maintenance equipment that meet the City's specifications; and

WHEREAS, the City budgeted funds in the Vehicles account of the Fleet Services Fund in the amount of \$37,080; The total cost of the replacement unit is \$37,810, however, with the trade-in amount of \$5,000 the final cost is \$32,810 (\$4,270 under-budget); and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure one (1) asphalt patching trailer for the Streets Division of the Public Works Department from Spaulding Manufacturing, Inc. located at 5366 East Rd, Saginaw, Michigan 48601 in accordance with H-GACBuy cooperative contract #SM10-20, for a total amount not to exceed \$32,810.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:


Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2024008 for one (1) asphalt patching trailer for the Streets Division of the Public Works Department from Spaulding Manufacturing, Inc. located at 5366 East Rd, Saginaw, Michigan 48601 in accordance with the H-GACBuy cooperative contract #SM10-20, for a total amount not to exceed \$32,810, is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2024008 and a copy of the H-GACBuy cooperative contract #SM10-20 are on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
