

RESOLUTION R-2023-19

**A RESOLUTION AUTHORIZING THE PURCHASE OF GASOLINE AND DIESEL FUEL FROM
AL WARREN OIL CO. THROUGH THE JOINT PURCHASING PROGRAM WITH DUPAGE COUNTY**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the City participated in a joint bid led by DuPage County ("County") for the purchase of Gasoline and Diesel Fuel; and

WHEREAS, the County has publicly and competitively bid for Gasoline and Diesel Fuel; and

WHEREAS, the County awarded agreement #23-011-FM to Al Warren Oil Co. located at 1646 East Summer Street, Hammond, Indiana, for the purchase of Gasoline and Diesel Fuel and has made it available to other public entities; and

WHEREAS, the City budgeted funds in the Fleet Services Fund for a total amount of \$473,700 (\$279,800 for Gasoline and \$193,900 for Diesel); and

WHEREAS, the budgeted amount for gasoline and diesel fuel can only be estimated based on a myriad of variables that can affect the City's needs which in turn requires expenditure flexibility to accommodate those variables, in meeting the essential needs of the Public Works Fleet department; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Al Warren Oil Co. located at 1646 East Summer Street, Hammond, Indiana for the purchase of Gasoline and Diesel Fuel on an as needed basis through the County Cooperative Agreement #23-011-FM; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 365 with Al Warren Oil Co. for the purchase of Gasoline and Diesel Fuel on an as needed basis through the County Cooperative Agreement #23-011-FM at the Oil Price Information Service Low Chicago Rack Base price (Illinois Motor Fuel, Underground Storage Tank and Environmental Impact taxes included), plus a \$0.0450 administrative/delivery charge per gallon of gasoline or diesel fuel delivered for the period April 1, 2023 through March 31, 2024, with the option to extend for three (3) additional one-year terms; and that a copy of that certain City of Wheaton Agreement No. 365 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
