

RESOLUTION R-2023-26

A RESOLUTION AUTHORIZING THE PURCHASE OF STRUCTURAL SUPPORT BEAMS FOR THE CREEKSIDE BRIDGE REPLACEMENT PROJECT FROM VALMONT, INC. THROUGH ITS AUTHORIZED DEALER TWG INFRASTRUCTURE SOLUTIONS FOR A TOTAL AMOUNT NOT TO EXCEED \$174,183

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Creekside Bridge needs replacement due to deterioration of the timber pile support in the middle of the creek channel; which led the City to contract with Strand Associates, Inc. to design a new single span bridge structure which eliminates the installation of support piles in the middle of the creek channel and allows for efficient conveyance of storm water downstream; and

WHEREAS, Strand Associates, Inc. proposed that the Valmont, Inc. single span U-BEAM be used in the construction of the new bridge; and

WHEREAS, the Valmont, Inc. single span U-BEAM has lead times in excess of 10-14 weeks, and for the project to stay on schedule, the City needs to order the beams prior to April 10th to ensure delivery in mid-July; otherwise, delivery would not take place until December; and

WHEREAS, Valmont, Inc. is the sole source provider of this type of beam and only sells through authorized dealers. The only Illinois authorized dealer is TWG Infrastructure Solutions; and

WHEREAS, a total of \$700,000 is budgeted in the CY2023 Capital Projects Fund for the Creekside Bridge replacement; and

WHEREAS, both parties agree to the terms, conditions and pricing set forth in the proposal and purchase order for the Valmont, Inc. single span beams; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois, find it reasonable and appropriate to purchase structural support beams for a total amount not to exceed \$174,183.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:


Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2024028 for the purchase of structural support beams for the Creekside Bridge Replacement project from Valmont, Inc. through TWG Infrastructure Solutions, for a total amount not to exceed \$174,183, is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2024028 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary for the, or in the furtherance of, completion of the Purchase transaction.
