

RESOLUTION R-2023-25

**A RESOLUTION FOR THE IMPROVEMENT UNDER THE ILLINOIS HIGHWAY CODE
(2023 ROAD, SEWER, AND WATER REHABILITATION PROGRAM)**

BE IT RESOLVED, by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets be improved under the Illinois Highway Code (street listing attached as Exhibit A). Work shall be done by Contract.

BE IT FURTHER RESOLVED,

1. Approximately 43,740 SY of pavement overlay including spot curb & gutter, concrete road panel replacement, drive approach & sidewalk removal & replacement, HMA and PCC pavement milling, leveling binder, & surface course; 5,850 SY of reconstruction including pavement & base removal, aggregate & HMA base reconstruction, binder, & surface course; curb & gutter drive approach & sidewalk removal & replacement; storm & sanitary structure replacement; water main replacement; & landscaping along various streets in the City of Wheaton and shall be designated as Section 23-00128-00-FP.

That there is hereby appropriated the sum of TWO MILLION DOLLARS AND 00/100 DOLLARS (\$2,000,000.00) for the improvement of said section from the Local Public Agency's allotment of Motor Fuel Tax funds.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit four (4) certified copies of this resolution to the district office of the Illinois Department of Transportation.
