

**RESOLUTION R-2023-49**

**A RESOLUTION AUTHORIZING THE PURCHASE OF BULK ROCK SALT FROM  
COMPASS MINERALS AMERICA, INC. THROUGH THE JOINT PURCHASING PROGRAM WITH  
DUPAGE COUNTY TO BE PURCHASED ON AN AS NEEDED BASIS AT THE PRICE PER TON SET FORTH IN  
COMPASS MINERALS AMERICA, INC.'S COST PROPORSAL**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the City participated in a joint purchasing solicitation (Bid Number 23-057-DOT) led by DuPage County, which included a total of 37 surrounding communities, for Bulk Rock Salt; and

**WHEREAS**, DuPage County ("County") solicited bids in a public bidding process and bids were publicly opened and read on May 1, 2023, at 1:00 PM and Compass Minerals America, Inc. was determined to be the lowest, responsive, responsible bidder with a bid in the amount of \$78.31 per ton for standard delivery up to 130% of projected usage and a unit cost of \$83.31 per ton for 131% to 150% of projected usage (hereinafter "Joint Purchase Pricing"); and

**WHEREAS**, the City requested 2,000 tons of bulk rock salt through the joint purchase and is required to purchase 1600 tons (80% of the 2,000 ton order) of rock salt and can receive up to 2600 tons (130% of the 2,000 ton order) of rock salt for the price of \$78.31 per ton; and

**WHEREAS**, the City budgeted funds in the General Fund-Road Materials account for a total amount of \$267,730 for Bulk Rock Salt; and

**WHEREAS**, both parties agree to the terms and conditions and pricing set forth in the bid proposal and the agreement for Bulk Rock Salt; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Compass Minerals America, Inc. 9990 W. 109<sup>th</sup> Street, Ste. 100, Overland Park, KS 66210, for the purchase of Bulk Rock Salt on an as needed basis.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 382 with Compass Minerals America, Inc. for the purchase of Bulk Rock Salt on an as needed basis, in accordance with the Joint Purchase Pricing, for a one (1) year term, with the option to extend for three (3) additional one-year terms; a copy of that certain City of Wheaton Agreement No. 382 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
