

RESOLUTION R-2023-47

**A RESOLUTION AUTHORIZING THE AMENDMENT OF AGREEMENT NO. 366
WITH FLOCK SAFETY TO PROVIDE ADDITIONAL AUTOMATED LICENSE PLATE RECOGNITION
CAMERAS FOR A ONE (1) YEAR LEASE AND A TOTAL AMOUNT NOT TO EXCEED \$138,500**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, on March 20, 2023, the City Council approved Resolution R-2023-366 with Flock Safety for 20 Automated License Plate Recognition (ALPR) cameras to be installed on the City's arterial roadways to support Strategic Priority 3: Responsive and Efficient Services and Strategic Priority 4: Community Safety; and

WHEREAS, to further support Strategic Priority 3 and 4 the City applied for and secured funding from the Organized Retail Crime (ORC) Grant for 44 additional ALPR cameras for a one-year lease in the amount of \$138,500; and

WHEREAS, the additional ALPR cameras are to combat organized retail crime associated with the City's retail shopping complexes and downtown parking garages; and

WHEREAS, an amendment to the CY 2023 Budget will be presented for the additional ALPR cameras from Organized Retail Theft Grant Expenditures account (16010020-69255) from the ORC Grant Fund. The first-year cost of \$138,500 includes a one-time implementation cost of \$6,500. Subsequent years' budget costs will be resubmitted through the ORC Grant program; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to amend Agreement No. 366 with Flock Safety located at 1170 Howell Mill RD NW, Suite 210, Atlanta, Georgia, 30318 for the lease of 44 additional ALPR cameras.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton amendment to Agreement No. 366 with Flock Safety for ALPR cameras, related software, and cloud services for a one (1) year term and a total amount not to exceed \$138,500; and that a copy of that certain City of Wheaton amendment to Agreement No. 366 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
