

RESOLUTION R-2023-61

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 392 WITH
SUPERIOR ROAD STRIPING INC. FOR THERMOPLASTIC ROAD STRIPING SERVICES THROUGH THE JOINT
PURCHASING PROGRAM WITH DUPAGE COUNTY FOR A TOTAL AMOUNT NOT TO EXCEED \$70,000**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, DuPage County ("County") has publicly and competitively bid for Thermoplastic Road Striping Services; and

WHEREAS, the County awarded a contract to Superior Road Striping Inc. in Melrose Park, Illinois, for Thermoplastic Road Striping Services and has made the County contract available to other public entities; and

WHEREAS, it is determined that the contract with Superior Road Striping Inc. through the County's cooperative contract meets the City's needs; and

WHEREAS, the City budgeted funds in the General Fund for an amount of \$100,000 for Thermoplastic Road Striping Services; and

WHEREAS, the corporate authorities of the City of Wheaton find it reasonable and appropriate to enter into an agreement with Superior Road Striping Inc. located at 1980 N. Hawthorne Ave., Melrose Park, Illinois 60160 for Thermoplastic Road Striping Services through the County's cooperative contract #23-PVMKG-11-GM for a total amount not to exceed \$70,000.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 392 with Superior Road Striping Inc. for Thermoplastic Road Striping Services; and that a copy of that certain City of Wheaton Agreement No. 392 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
