

RESOLUTION R-2023-65

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 403 WITH
TRIGGI CONSTRUCTION, INC. FOR THE 2023 FALL NEW SIDEWALK PROGRAM
FOR A TOTAL AMOUNT NOT TO EXCEED \$1,416,738.30**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City solicited an Invitation to Bid package (ITB Number 23-122) for the 2023 Fall New Sidewalk Program; and

WHEREAS, Triggi Construction, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$1,416,738.30; and

WHEREAS, the City budgeted funds in the Capital Projects Fund in an amount of \$1,7000,000 for the 2023 Fall New Sidewalk Program. The total cost of the project (\$1,416,738.30) will be funded using an ARPA grant; and

WHEREAS, both parties agree to the terms and conditions set forth in the ITB package and the agreement contained in the City's bid package for the 2023 Fall New Sidewalk Program; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Triggi Construction, Inc. located at 1975 Powis Rd., West Chicago, Illinois, 60186 for the 2023 Fall New Sidewalk Program for a total amount not to exceed \$1,416,738.30.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 403 with Triggi Construction, Inc. for the 2023 Fall New Sidewalk Program; and that a copy of that certain City of Wheaton Agreement No. 403 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
