

**RESOLUTION R-2023-69**

**A RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) 2024 FORD F250 PICKUP TRUCKS FROM SUTTON FORD IN ACCORDANCE WITH THE NORTHWEST MUNICIPAL CONFERENCE SUBURBAN PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$95,964**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the City is a member of the Northwest Municipal Conference ("NWMC"), a corporate organization representing municipalities and townships located within the State of Illinois and Counties of Cook, DuPage, Kane, Lake, and McHenry; and

**WHEREAS**, the City participates in the NWMC Suburban Purchasing Cooperative ("SPC"), which permits local governments to purchase commodities and services according to contracts negotiated by the NWMC, resulting in significant savings for the City; and

**WHEREAS**, the SPC contract #221 has been publicly and competitively bid for Ford F250 Pickup Trucks; and

**WHEREAS**, the SPC has identified Sutton Ford located in Matteson, Illinois, as the low responsible bidder for SPC cooperative contract #221; and

**WHEREAS**, the City budgeted funds in the Vehicles account of the Fleet Services Fund in an amount of \$78,689 for the purchase of Units 19 and 36 with associated equipment and reserves are available to accommodate the additional cost; and

**WHEREAS**, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure two (2) 2024 Ford F250 Pickup Trucks for the Fleet Division of the Public Works Department from Sutton Ford located at 21315 Central Avenue, Matteson, Illinois 60443 in accordance with SPC cooperative contract #221 for a total amount not to exceed \$95,964.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2024067 for two (2) 2024 Ford F250 Pickup Trucks for the Fleet Division of the Public Works Department from Sutton Ford located at 21315 Central Avenue, Matteson Illinois, 60443 in accordance with SPC cooperative contract #221, for a total amount not to exceed \$95,964 is hereby authorized (the "Purchase").

A copy of the City's Purchase Order #2024067 and a copy of the Suburban Purchasing Cooperative contract #221 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
