

RESOLUTION R-2023-89

A RESOLUTION AUTHORIZING EXECUTION OF A LOCAL PUBLIC AGENCY JOINT FUNDING AGREEMENT FOR CONSTRUCTION WORK WITH THE ILLINOIS DEPARTMENT OF TRANSPORTATION FOR FEDERAL PARTICIPATION IN THE LORRAINE ROAD RESURFACING PROJECT

WHEREAS, the City of Wheaton, DuPage County, Illinois, and the State of Illinois Department of Transportation jointly propose to resurface FAU Route 2575 known, locally as Lorraine Road, between Hill Avenue and Roosevelt Road (omitting Hill Avenue to Harwarden Street) in Wheaton, Illinois; and

WHEREAS, it is necessary for the City and State to enter into an agreement to receive Federal Fund participation for the construction cost and construction engineering costs of the subject project; and

WHEREAS, the improvement requires matching funds.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that the Mayor is authorized to execute a Local Public Agency Joint Funding Agreement for Construction Work with the Illinois Department of Transportation for the Federal participation in the construction of the resurfacing of Lorraine Road (FAU Route 2575), Project No. IQU3(739), Job No. C-91-074-23, Section 22-00127-00-RS.

BE IT FURTHER RESOLVED that the City authorizes the expenditure of Eighty-Four Thousand and Twelve and no/100 Dollars (\$84,012.00), or as much as may be needed to match federal funds in completion of the subject project and furthermore agrees to pass a supplemental resolution if necessary to authorize additional funds for completion of the project.

BE IT FURTHER RESOLVED that this resolution will become Attachment 3 of the Agreement and that the City Clerk is directed to transmit three (3) copies of the Agreement and Resolution to IDOT District 1 Bureau of Local Roads and Streets.
