

RESOLUTION R-2023-102

A RESOLUTION AUTHORIZING THE PURCHASE OF SNOWPLOWING EQUIPMENT AND UPFITTING SERVICES FROM HENDERSON PRODUCTS, INC. IN ACCORDANCE WITH THE NATIONAL PURCHASING PARTNERS COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$385,044

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, National Purchasing Partners ("NPP") is a national cooperative procurement organization based in Seattle, WA owned by non-profit hospitals. The City is a member of NPP and participates in NPPGov which is the government division of NPP. NPPGov allows local governments to purchase commodities and services according to contracts negotiated by NPPGov, resulting in significant savings for the City; and

WHEREAS, NPPGov contract #PS22170 has been publicly and competitively bid for Roadway Clearing & Seasonal Management Systems; and

WHEREAS, NPPGov has identified Henderson Products, Inc. in Huntley, Illinois as the low, responsive, responsible bidder for NPPGov contract #PS22170; and

WHEREAS, the City budgeted funds in the CY2023 Vehicles account in the Fleet Services Fund for an amount of \$522,280 for the replacement of Units 24 & 26, related snow plowing equipment and upfitting services; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure snow plowing equipment and upfitting services for replacement Units 24 & 26 from Henderson Products, Inc. located at 11921 Smith Drive, Huntley, Illinois 60142 in accordance with NPPGov contract #PS22170 for a total amount not to exceed \$385,044.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2024113 for the purchase of snow plowing equipment and upfitting services for replacement Units 24 & 26 from Henderson Products, Inc. for a total amount not to exceed \$385,044, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2024113 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
