

RESOLUTION R-2024-05

**A RESOLUTION AUTHORIZING THE PURCHASE OF FOUR (4) SANDBAGGER MODEL – II SANDBAGGING MACHINES FROM THE SANDBAGGER LLC FOR A TOTAL AMOUNT NOT TO EXCEED \$88,740**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City solicited a Request for Quote package (RFQ Number 24-08) for the purchase of four (4) Sandbagging Machines and The Sandbagger LLC was determined to be the lowest, responsive, responsible vendor with a bid amount of \$88,740; and

**WHEREAS**, the City budgeted funds in the Sanitary Sewer Fund and Storm Sewer Fund in an amount of \$100,000 for four (4) Sandbagging Machines; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the RFQ and the purchase order for four (4) Sandbagging Machines; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois, find it reasonable and appropriate to enter into a purchase order with The Sandbagger LLC located at 765 S. Rt. 83, Elmhurst, Illinois 60126 for the purchase of four (4) Sandbagging Machines for a total amount not to exceed \$88,740.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2025003 for the purchase of four (4) Sandbagging Machines from The Sandbagger LLC for a total amount not to exceed \$88,740, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2025003 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in the furtherance of, completion of the Purchase transaction.
