

RESOLUTION R-2024-28

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 445 WITH
PLOTE CONSTRUCTION, INC. FOR ASPHALT MATERIALS TO BE PURCHASED ON AN AS NEEDED BASIS
AT THE PRICING SET FORTH IN PLOTE CONSTRUCTION'S COST PROPOSAL**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City solicited an Invitation to Bid package (ITB Number 24-60) for the purchase of Asphalt Materials and Plote Construction, Inc. was determined to be the lowest, responsive, responsible bidder with a bid amount of \$431,800; and

WHEREAS, the City budgeted funds in multiple accounts (General, Capital Projects, Water, Sanitary Sewer, and Storm Sewer Funds) for a total amount of \$462,700; and

WHEREAS, the budgeted amount for asphalt materials and reserves can only be estimated based on a myriad of variables that can affect the City's needs which in turn requires expenditure flexibility to accommodate those variables, in meeting the essential need of the Public Works department; and

WHEREAS, both parties agree to the terms and conditions, and pricing set forth in the bid proposal and the agreement contained in the City's bid package for Asphalt Materials; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Plote Construction, Inc. located at 1100 Brandt Drive, Hoffman Estates, Illinois 60192 for Asphalt Materials to be purchased on an as needed basis.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 445 with Plote Construction, Inc. for Asphalt Materials: a copy of that Agreement is on file with the City Clerk's office, and which is incorporated herein as if fully set forth as Exhibit A.
