

RESOLUTION R-2024-34

**A RESOLUTION AUTHORIZING THE PURCHASE OF DUTY WEAPONS AND ACCESSORIES
FROM KIESLER POLICE SUPPLY FOR A TOTAL AMOUNT NOT TO EXCEED \$53,847.85**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City solicited an Invitation to Bid package (ITB Number 24-52) for the purchase of Duty Weapons and Accessories and Kiesler Police Supply was determined to be the lowest, responsive, responsible bidder with a bid amount of \$53,847.85, which reflects the trade-in of existing duty weapons and accessories; and

WHEREAS, the City budgeted funds in the Operating Equipment account of the Capital Equipment Replacement Fund in an amount of \$100,000 for Duty Weapons and Accessories; and

WHEREAS, both parties agree to the terms and conditions forth in the ITB and the purchase order for Duty Weapons and Accessories; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois, find it reasonable and appropriate to enter into a purchase order with Kiesler Police Supply located at 2802 Sable Mill Rd, Jeffersonville, Indiana 47130 for the purchase of Duty Weapons and Accessories for a total amount not to exceed \$53,847.85.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2025039 for the purchase of Duty Weapons and Accessories for a total amount not to exceed \$53,847.85, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2025039 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in the furtherance of, completion of the Purchase transaction.
