

**RESOLUTION R-2024-35**

**A RESOLUTION FOR IMPROVEMENT  
UNDER THE ILLINOIS HIGHWAY CODE  
(2024 ROAD, SEWER, AND WATER REHABILITATION PROGRAM)**

**BE IT RESOLVED**, by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets be improved under the Illinois Highway Code (street listing attached as Exhibit A). Work shall be done by Contract.

**BE IT FURTHER RESOLVED**, that the proposed improvement shall consist of approximately 76,056 SY of pavement overlay including spot curb and gutter, concrete road panel replacement, drive approach and sidewalk replacement, HMA and PCC pavement grinding, leveling binder, followed by surface course; 590 SY of reconstruction including pavement and base removal, aggregate and HMA base reconstruction, binder, and surface course; curb and gutter drive approach and sidewalk removal and replacement; storm and sanitary structure replacement; water main replacement; landscaping along various streets in the City of Wheaton and shall be designated as Section 24-00129-00-FP.

**BE IT FURTHER RESOLVED**, that there is hereby appropriated the sum of TWO MILLION, ONE HUNDRED THOUSAND AND 00/100 DOLLARS (\$2,100,000.00) for the improvement of said section from the Local Public Agency's allotment of Motor Fuel Tax Funds.

**BE IT FURTHER RESOLVED**, that there is hereby appropriated the sum of FIVE HUNDRED AND EIGHTY THOUSAND, NINE HUNDRED AND EIGHTY SEVEN AND 13/100 DOLLARS (580,987.13) for the improvement of said section from the Local Public Agency's allotment of Rebuild Illinois Funds.

**BE IT FURTHER RESOLVED**, that the City Clerk is hereby directed to transmit four (4) certified copies of this resolution to the district office of the Illinois Department of Transportation.

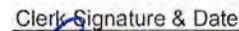
